Additional Details relating to the Baseline Emissions calculations.

We continue to develop and make improvements on the quantity and diversity of data we are able to gather for Scope 3. This currently includes Aeroplane travel, other business travel, purchased goods and services, employee commuting and fuel & energy related activities. As a supplier of labour rather than a manufacturer, producer or supplier of products, our upstream and downstream transportation and distribution emissions are negligible and are therefore not currently included in our figures.

Emissions reduction targets

We project that total carbon emissions will decrease over the next seven years to 1,985 tCO_2 e by 2030. The aim is a reduction of over 57% on our scope 1 and 2 figures (for 2023 we have exceeded this and achieved a 70% reduction of our scope 1 and 2 emissions) and 30% on scope 3. This is largely driven by our ongoing increase in electric vehicles and moving to 100% renewable energy in our offices, plus engaging with our major suppliers on their net zero commitment.

It should be noted that the significant reductions in emissions in 2020 is not a true reflection of our usual operational emissions. This was mainly driven by the shift to working remotely and the associated sharp reduction in office usage and travel as a result of the global COVID-19 pandemic.

Carbon reduction initiatives

	Sustainable mobility policy	Fleet is the largest contributor to our scope 1 emissions. To reduce our fleet emissions we are focusing on moving our company car fleet to electric vehicles as lease terms end. At the end of 2023, 65% of our fleet were electric vehicles.	
	100% renewable energy and energy efficient buildings	We have achieved 100% renewable electricity in all buildings under our control for 2023. We further reduce our use of energy by utilising energy efficiencies in our buildings. This includes PIR controlled LED lighting reducing our thermostats by 1°C and reducing and maximising office space.	
-+	Sustainable business travel	We continue with our endeavours to keep travel as low as possible and to use the most sustainable methods available for all travel.	





Supplier engagement strategy


We will engage our suppliers to reduce emissions as well.

By 2027, as part of the supplier relationship management programme, global suppliers responsible for 30% of our scope 3 emissions will be required to commit to Net Zero.

Randstad's road to Net Zero takes an organic flow of emission reduction into account and ensures we start ambitious to create space for future growth.

An ambitious start in our move to electric vehicles, energy efficient buildings, use of renewable energy and our sustainable travel policy will lead to a higher reduction than the required SBTi minimum.

Carbon reduction: projected v actual



Although our scope 1 and 2 emissions have reduced, the graph shows a further increase in emissions for 2023. This is due to better reporting and information gathering of our scope 3 data. We are confident this will reduce as we further engage with our suppliers and require them to commit to Net Zero, if they have not already done so.
